Studies

She graduated from the Athens School of Philosophy (Department of Byzantine and Modern Greek Studies) in 1985. Her dissertation entitled "Cultures maraîchères dans la Méditerranée. Les transformations de la plaine et de la société argoliques, 1860-1910" was prepared in the period 1991-1995, at the European University of Florence, where she was awarded the Doctor's degree in History in 1995.

Research – professional activity

- -She participated in the classification of the Municipal Archive of Ermoupolis in 1981, 1982 and 1985.
- -She worked at the National Bank History Archive, 1983 -1991 and 1995 -2003.
